Autism Tasmania wishes to acknowledge the Aboriginal people as the traditional owners of our land. We pay our respects to their elders past and present. Autism Tasmania celebrates Aboriginal living culture and their valuable contributions to the Tasmanian community.

What is Autism?

"Autism is a life-long developmental disability that affects how a person communicates with, and relates to, other people. It affects how they make sense of the world around them". (National Autistic Society, UK).

Autism Spectrum Disorder is a neurodevelopmental condition that affects an **individual's communication, socialisation and behaviours**. To be diagnosed with an ASD, an individual has shown challenges in the areas of:

- Communication: verbal and non-verbal,
- Social understanding and interactions,
- Fixated interests, activities and repetitive behaviours, and
- Sensory aspects of the environment.

It is not known what causes an individual to have an Autism Spectrum Disorder. Much research is being done to try to find out more. At this point it is believed to result from changes to brain development which may be caused by a combination of reasons, including environmental and genetic factors or a combination of both environment and genetic factors.

Autism is not caused by parenting styles or social circumstances. There is an increased chance of having another child with an ASD, if there is already a child in the family with an ASD, but no specific genes have yet been proven to cause ASD. There is no valid research or evidence to link autism with childhood vaccinations or other medical treatments.

President of Autism Tasmania

In the 12 months since I last reported to Members on behalf of the Committee on the health and performance of the Association, the most obvious change has been of CEO. Andrea Brumby chose to return to the education sector from which she had taken leave; Terry Burke joined in a managed transition in January this year, bringing a depth of management experience from a lengthy career in the financial services sector and then more recently, four years in the community sector.

Two broad sets of imperatives have shaped our thinking, actions and results over the period; both had their beginnings in the very strong foundation set in place during **Andrea's tenure as CEO and subsequently** have been brought to fruition or built upon during the eight months that Terry has been in the role.

Externally, we spent considerable time in the latter half of 2012 developing a 5 year strategic plan which continues to be a work in progress. Only months ago the talk was about a national disability insurance scheme – **remember NDIS "every Australian counts"**. The idea clearly resonated with the Australian community and politically as a result; it truly was an idea whose time had come. There are now pilot programs in three states and transition arrangements evolving for service organisations, people with disability, their families and carers under DisabilityCare Australia. I believe the real value of the work to date has been in starting the conversations we must now **have about Autism Tasmania's role and** how we position the Association strategically in this radically changing landscape.

Internally, the imperatives have been to turn around the deficit we carried into this financial year and create a solid financial

and service base for the immediate future. **It's satisfying to report that we moved into** surplus by 30 June 2013, well ahead of our original expectations. We have secured a further three years of funding through our primary funding agreement with DHHS and after the expiry of our present HCWA funding contract in June 2014, it is anticipated that we will be offered a two year contract to align with the full introduction of DisabilityCare Australia.


When we add some fortunate support with one-off funding and several fundraising opportunities – some repeatable, with scope to increase their impact, we have a solid backdrop for future planning. This period gives Autism Tasmania the opportunity to plot its course as referred to earlier and to create the income streams necessary for a sustainable business model for the longer term, while continuing to prudently use its existing resources to **underpin those core activities that we're** contracted to provide or choose to do.

Such a positive outcome hasn't been achieved by chance. Administratively, through the work of our CEO and Treasurer, we have clear, relevant and timely financial reports and an excellent budgeting process to enable good decision-making and track performance. Payroll processing and award compliance has been successfully outsourced; review of our policies and procedures in compliance with the new Work Health and Safety environment; data collection and management has improved significantly with the completion of the database. As well as securing the lease of our Launceston premises an agreement has been reached to extend our lease of our Moonah offices, our improved financial situation has allowed improvements to the amenity for staff in both locations – with Launceston staff returning to their former location.

Our service offerings have continued to be underpinned by our DHHS funding and the HCWA program, direct information and support to families through a re-vamped and less-dependent social/support group model, our contracted activities of Positive Partnerships and Early Days Workshops and introduction of The Zone for high-functioning grade 5-8 students on the autism spectrum. Experience gathered over the year had led to a re-balancing of staff responsibilities and other resources to meet particular needs across the regions.

A particular satisfaction has been **sponsoring Emily Brake's participation** in the Asia Pacific Autism Conference *Future Leaders Program* – Emily is a young **woman who has Asperger's Syndrome**, who participated along with other young people on the autism spectrum from around Australia at this valuable program in conjunction with APAC 2013 in Adelaide.

All in all, a solid foundation on which to plan for our long-term future. Our thanks as a Committee go to our very able and responsive staff. In particular, to Terry Burke as CEO - we have seen the impact of his experience in concentrating efforts on those matters most important to our long-term sustainability and in building the external relationships essential to this. Congratulations and well-done to all.

The Year in Review

As previously reported 2012-2013 has been a year of consolidation that has seen the organisation strengthen its financial position. This has been achieved by a combination of activities, gaining some additional programs and securing some additional one off funding. The highlights included two well attended workshops by Professor Tony Attwood in Launceston in November 2012 and Professor Jacqui Roberts in Hobart in April 2013. We were very fortunate to secure these two internationally renowned speakers that were strongly supported by the positive feedback received from participants.

Autism Tasmania is proud to co-ordinate and deliver the Positive Partnerships Parent/Carer Workshops in Tasmania. This national partnership between education and the autism community supports parents of school aged children through workshops and information sessions and provides professional development for teachers, school leaders and other school staff.

We were fortunate to secure grant funding **from the Clarendon Childrens' Home Inc** that allowed us to roll out the Zone Project throughout Tasmania. This project is designed to provide a social club and activities for high functioning ASD students across grades 5 to 8. This fills a significant gap and the results have been truly amazing. This is continuing into the current year and we will seek to provide this program to further groups of children going forward.

Through Community Grant Funding from the Launceston City Council our libraries have been properly catalogued, a lending system established and additional resources purchased. The library catalogue is now available via our website. This provides a readily available resource to our members on ASD and other relevant topics.

Autism Awareness month saw the inaugural **"Making Futures Brighter Walk"** at the Domain Athletic Centre which received good media coverage and is a platform from which we can build. Other activities during the month included a Walkathon/Family Picnic at St Leonards, Public Sausage Sizzle at Bunnings Warehouse in Kings Meadows and an evening and afternoon with Dr Wendy Lawson in Launceston and Devonport respectively.

A particular highlight of the year was the Ride for Autism Awareness by Clinton and Crystal Taylor. This event received tremendous media coverage as Clinton, supported by his family cycled around Tasmania and not only raised awareness of autism, but contributed in excess of \$5000.00 to Autism Tasmania. Planning is underway for a bigger and better event in 2014.

The year again saw the continued valuable support received from both businesses and individuals alike which are acknowledged within this report. We are very fortunate and grateful to receive this support that augments our ability to deliver services to the Autism community.

Program Delivery

Autism Tasmania has increased our reach in the last financial year to individuals, families and the community as evidenced by our activity. Increasingly social media and our newly launched website are becoming significant touch points for our organisation. It is this medium that allows us to communicate quickly with our membership and families.

Following the launch of our website in late 2012 the team at Autism Tasmania was thrust into action following the devastating bushfires at Dunalley, the Tasman Peninsula, Bicheno and the Derwent Valley. The responsiveness of the staff to the emergency has been recognised with a nomination for the 2013 Innovation Awards.

The staff through their amazing efforts, in the middle of a holiday period, mobilised to ensure that families in the affected areas had access to resources to support the additional needs of the people with Autism.

This included the pulling together of resources for emergency kits which contained small sensory items such as fiddle toys and other autism specific items that were donated along with some general information including tips and suggestions about how to support children and adults during this stressful time, some examples of social stories to help increase their children's understanding of what was happening around them and to help decrease their anxiety levels about the fires. Over 80 emergency kits were distributed.

This is only an example of the commitment of all our staff at Autism Tasmania that daily support families and the community around the State to improve understanding of the spectrum condition that is autism.

Our support covers the lifespan from our Autism Advisors providing support and information to parents that have recently received a diagnosis for their child to our Autism Support staff who may be providing support to a parent of an older child on the spectrum or an adult that has only recently received a diagnosis looking for support or referrals.

The clients registered in the Helping Children with Autism program increased by 23% to 161 in the year and our family and community support which includes training and social support groups reflects a significant increase from the previous year.

Early Days Workshops had a solid year with us exceeding our contract target by 13%. We are looking forward to rolling out this program again in 2014 including a number of newly developed shorter training courses.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2013

Note 1 Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act Tasmania. The committee has determined that the association is not a reporting entity.

The Association is a not for profit entity for financial reporting purposes. The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

(a) Income Tax

Autism Tasmania Incorporated is exempt from income tax.

(b) Property, Plant and Equipment (PPE)

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

(c) Employee Provisions

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

(d) Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(e) Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(f) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(g) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

(j) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

(l) Accounts payable and other payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

Report on the Financial Report

We have audited the accompanying financial report, being a special purpose financial report, of Autism Tasmania Inc, which comprises the statement of financial position at 30 June 2013, statement of comprehensive income, statement of changes in equity, for the year then ended, notes comprising a summary of significant accounting policies, other explanatory notes, and the statement by members of the Board.

Board's Responsibility for the Financial Report

The Board of the Association is responsible for the preparation and fair presentation of the financial report and has determined that the accounting policies described in Note 1 to the financial statements, which form part of the financial report, are appropriate to meet the requirements of the *Associations Incorporations Act Tasmania 1964*, and are appropriate to meet the needs of the members. The board's responsibility also includes designing, implementing and maintaining internal control relevant to the preparation and fair presentation of the financial report that is free from material misstatement; whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

Auditor's Responsibility

Our responsibility is to express an opinion on the financial report based on our audit. No opinion is expressed as to whether the accounting policies used, as described in Note 1, are appropriate to meet the needs of the members. We conducted our audit in accordance with Australian Auditing Standards. These Auditing Standards require that we comply with relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance about whether the financial report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial report. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial report, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial report in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Association's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial report.
