

President's Report

Rewards and Challenges: Inclusion in Practice is the title of the final document just released by the Education Department after almost 18 months of investigation. Rewards and Challenges could also be the title of the past 12 months for Autism Tasmania.

Our last AGM came after the very successful National Conference and I believe, made those within the education sector, in particular, take note of just how important Autism Spectrum Disorder is and will continue to be in our State, particularly in the provision of services to our young people.

In November '99 the Autism Forum took place in Launceston. There were 19 presentations from both parents and professionals working in the field of Autism Spectrum Disorder. The focus was Autism and disappointingly, the outcomes of the day have not reached fruition. Although a majority of presenters made very positive comments about the Autism Consultants role, everybody acknowledged the very real difficulty of one person being able to service the entire state. The realistic solution would be to have a consultant in each region. Unfortunately this has not occurred and the role of the current consultant Kathy Gill has been very significantly altered. This means that no individual consultations will occur to allow for an increase in the level of Professional Development particularly in regard to District Support Services.

Autism Tasmania has written to the Education Department expressing our concern and seeking clarification regarding the needs of the children, families and schools and how these needs are to be met. The reply from Kate Shipway, Director Equity Standards did not directly address our concerns but made the point that "recommendations and implementation plans (from the Inclusion Review) will be finalised soon and clarification of these roles will begin as soon as possible."

As mentioned, we have been involved over the past 18 months with the Inclusion in Practice Review as part of the Reference Group. Autism Spectrum Disorder was well represented with 2 delegates from Autism Tasmania and 2 from the YAST group. The impact of Autism Spectrum Disorder experienced by all parties involved in the inclusion process - children, parents, teachers and teacher-aides - was well documented by all those with an interest in this area. Working together with YAST meant a very positive outcome for Autism, evident in the release of the final document which makes direct reference to Autism Spectrum Disorder in two of the recommendations, All parents with children involved in regular or special school settings should take time to read the recommendations made. Another positive outcome from this process is that university students will have Autism Spectrum Disorder included in their studies, with the hope that this will have a positive impact on the education system in 4/5 years time.

Our partnership with Giant Steps continues as a very positive and reciprocal one. The Centre celebrated its 5th birthday this year in a much more secure position than it was last year and a very strong sense that its future is assured. With registration extended to cover secondary students, many of the children can continue on at the Centre well into their teenage years. Giant Steps is currently considering the specific needs of adolescent students to extend it's programs, as well as looking at post-school options. Each of the older group of students is involved in inclusion in regular schools as well as activities at the Centre. The Centre also recognises a need for more effective early intervention and flexibility in how these services can best be provided. The recently launched consultancy service provides therapists, on a fee basis, to help parents and teachers with specific programs or problems. Giant Steps is also looking more flexible enrolment options.

Regular, ongoing contact between YAST and Autism Tasmania has continued during the last year. This can only be seen as a positive step forward in our endeavours to educate people regarding Autism Spectrum Disorder. Both groups being involved in the Autism Forum and the Inclusion Review has meant constant contact with each other, ensuring that all areas of the disorder were covered in our written submissions. YAST also has a representative on our current committee and have done so for the past 4 years. We look forward to this relationship continuing.

The services we provide to our parent members are of great importance when planning activities for our calendar. However, despite taking into account comments from past seminars (what would you like to see presented?) attendance at seminars presented this year has not been as strong as previous years. The attendance by professionals however has been excellent. The current newsletter asks all members to comment on this and let the committee know. As one parent commented "maybe night-time presentations would be better as they don't interfere with precious family time at weekends." This is an area we may need to explore in 2001.

Historically, parent support is an area where there have been mixed views. Do parents want to get together on a regular basis or do they have enough support elsewhere? Regional functions have been successful in the past and need to be investigated again as there are many new parents joining who need support and information. Recently a new support group was established on the North-West Coast out of a need to talk to others in similar situations and share information.

Both the North-West and North have very successful Asperger Support Groups which meet on a regular basis. A group of parents and young people with Asperger Syndrome met informally in Hobart with Wendy Lawson when she visited recently and this may be the catalyst for a support group in Hobart if those involved see the need.

We continue to advertise our Library (books, videos, articles and audiotapes), however, few people actually take advantage of what we have to offer. This may be because our libraries are located in private homes, making it difficult for some to access. Recently Autism Tasmania took up the offer of office space on the North-West Coast (Burnie). We share

with the Epilepsy Association and the Huntington Disease Support Group, pay minimal rent and staff it with volunteers. This means we can house the library and hold meetings in a central location for our members. It's a 12-month trial and we will watch library usage closely now it is more accessible.

An area of growing need within the Autism community is services for our adolescents and young adults. Few services exist and those that do are not replicated in each region of the State. Recent visits by high-profile people such as Wendy Lawson and Temple Grandin are beginning to change our understandings of the capabilities of people who have previously been viewed very differently. We need to keep this focus going and build on it, providing a basis for the future.

Over the past twelve months we have tried to provide a range of interesting and practical activities,

In December, Peta Kelty and Amelia Bishop took us Beyond Picture Exchange; in May, Margaret Hill and Shirley Roberts from Irabina SDS focused on Communication and Behaviour Management for Children with High Needs and in July, Jenny Butler presented her wonderful Sexuality Workshop.

For many, the highlight was Temple Grandin's visit in April and the opportunity to hear from a person who has High Functioning Autism, is an acknowledged international specialist in their field, a well-published author and is so effectively help us understand Autism from the inside.

"Autism – A World Of Difference" was the phrase adopted by the National Autism Council of Australia for this year's National Autism Awareness Week. Planning began in November last year with special emphasis on encouraging all State and private schools in Tasmania to consider Autism Tasmania as one of the charities to which they donate during 2000. Disappointingly, after our follow-up in early April, only three schools replied. Students at each raised money selling buttons for us and subsequently were issued with an Autism Tasmania Certificate of Appreciation. Although the direct response was disappointing we know that more than those 3 schools displayed the information sent to them.

Southern Cross produced a new community announcement using the theme "Autism - A World Of Difference", however despite much consultation with the producer about what we envisaged we were disappointed with the finished product but thrilled that Robyn Moore agreed to do the voice-over.

Button Day for the week was low-key with few people being able to volunteer during the week. Those who did venture out onto the streets did a wonderful job spreading the word and through badge sales raised almost \$1000.

Parent Information Kits are now being distributed for a minimal cost and we have sold quite a few to both parents and professionals. A database has been prepared regarding the distribution of the kits so that updated sheets can be sent out when necessary.

A combined submission from Autism Tasmania and Giant Steps was prepared for funding from the Apex Trust Fund. If successful this will be used to establish an Autism Register for Tasmania. This will be particularly useful when talking to governments and service providers as we will know the spread of people that need services.

It has been a busy year, especially after an extremely hectic1999 preparing for the conference. The committee of only 7 (a full committee is 10) have worked extremely hard taking on more than one "portfolio" at a time which is no mean feat when most work full time in paid employment. As meetings fall on weekends there has been the sacrifice of family time and travel to our central point of Ross for a hard day of work. I have greatly appreciated the work the Committee has done over the past 12 months and the support they have given me and to each other; we really have been a happy committee. This year we say goodbye to Rosanne Lay and Kathy Gill who are both stepping down from the committee after several years. The work they have done during their time on the committee has been greatly appreciated, especially so during the time of organising the conference. We wish them all the best and know they will enjoy their newfound time with their families.
